



## AMBIT KICKOFF 2024 GIVEAWAY RULES

### 1. SPONSOR

The sole sponsor of this Sweepstakes is Ambit Holdings, LLC ("Sponsor").

### 2. HOW TO ENTER

Each participant who registers for Kickoff 2023 ("Kickoff") and attends in person or online will be eligible to be entered in a random drawing for a chance to win a prize. For in person attendees, at check in to the Kickoff on February 24, 2024, each eligible participant will be provided with a door prize ticket with a randomly assigned number. This number is the participant's entry into the drawing. **You must place the door prize ticket with number in the drawing tumbler during the event as directed by event staff to be entered into the drawing. Three (3) winning numbers will be drawn randomly on Saturday, February 24, 2024, during the Kickoff event.** For virtual attendees, once you check in to watch the event online, you are eligible to win a prize. Your name will be included on a virtual wheel which will spin to select a winner by random during the event. Three (3) winners will be selected at random on Saturday, February 24, 2024 during the Kickoff event. Please note: There is no purchase necessary to enter. Participation in the drawing is not required, nor is the drawing the main or sole reason why you should participate in Kickoff. Among other benefits, Kickoff offers its participants educational sessions, informative presentations and networking opportunities. All entries become the sole and exclusive property of Sponsor. Entries will not be returned and receipt of entries will not be acknowledged.

### 3. ELIGIBILITY

Eligibility is limited to persons at least twenty-one (21) years of age, who are legal residents of the United States or its territories and possessions, and who are registered and attend Kickoff in person or online. Each participant who registers for Kickoff by 11:59 AM CST the morning of February 24, 2024, and attends in person or online will be eligible for the Sweepstakes. **Limit of one (1) entry per person.** The drawing is subject to all applicable federal, state and local laws and regulations and void where prohibited. Employees (and their immediate families and household members) of Ambit, its parents, affiliates, subsidiaries, and advertising and promotion agencies are not eligible to participate in the drawing. The Sweepstakes is open to Kickoff registrants who attend in person or online and who are consultants or other service providers of Sponsor's affiliates and is not offered in connection with or incidental to the promotion, advertising or sale of consumer products or services.

### 4. PRIZES

There are six (6) total prizes available. There will be six (6) prize winners from the eligible participants of the in-person Kickoff experience. The prize is a \$250 Visa Giftcard (ARV \$250).

The Total ARV of all of the prizes is \$1500. All taxes and other fees on the prize are the sole responsibility of the winner. Winner understands that Sponsor is required by law to issue him/her an Internal Revenue Service 1099 Tax Form for the value of prize won and winner agrees to fully cooperate with Sponsor or its representative in this regard, including by providing all required tax forms. The prizes have no cash value, cannot be redeemed for cash, and are not transferrable, extendable, or exchangeable. All other prize expenses not specified herein are the sole responsibility of the prize winner. Actual value of the prize may differ from approximate retail value. If actual value is less than approximate retail value, winner will NOT receive the difference.

### 5. RANDOM DRAWINGS

A total of six (6) in-person prize winners will be selected at random to take place on February 24, 2024, from all eligible entries received up until 11:59 AM CST the morning of the same day. The six (6) winning numbers will be drawn randomly from a tumbler for in person attendees and from a virtual wheel for online attendees. The odds of winning depend on the number of eligible entries received. Approximately 1000 participants will be entered into the drawing. Ambit's determination of the winner by the random selection of an entry will be final and binding. In the event a selected winning entry is discovered to be invalid for any reason whatsoever or the person who submitted the winning entry fails to comply with these Official Rules prior to delivery of the prize, the prize may be forfeited.

### 7. PRIZE WINNER NOTIFICATION AND ANNOUNCEMENT

Upon drawing, the prize winner will be notified immediately by general public announcement at the Kickoff event. For In person attendees, the prize must be claimed at the time the winner is announced or it will be forfeited and another winner will be selected by random drawing. **YOU MUST BE PRESENT TO WIN. NO EXCEPTIONS.** All prizes will be handed to the prize winner at the event. For virtual attendees, the winner will be contacted the day of the event. The prize must be claimed by 5:00pm CST on Saturday, February 24, 2024 or it will be forfeited. All prizes will be mailed to the prize winner.

### 8. NO WARRANTIES

Sponsor makes no warranties whatsoever with regard to the drawing and prize. Sponsor reserves the right to substitute a prize of equal or lesser value in the event of unavailability.

### 9. LIMITATIONS ON LIABILITY

All issues and questions concerning the construction, validity, interpretation and enforceability of these rules, or the rights and obligations of participants or Sponsor in connection with the drawing/ shall be governed by and construed in accordance with the internal laws of the State of Texas without giving effect to any choice of law of conflict of law rules or provisions that would cause the application of any other state's laws. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
